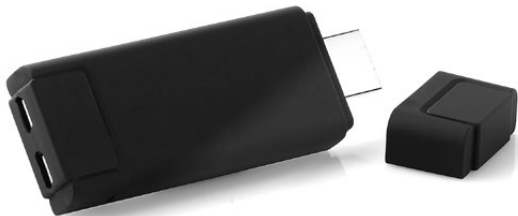

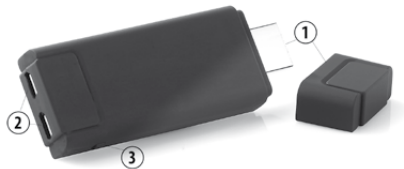

## INBETRIEBNAHME

1. Schieben Sie den TV-/HDMI-Stick in den HDMI-Anschluss des Anzeigegerätes (Fernseher, Monitor oder Projektor) – verwenden Sie ggf. das HDMI-Verlängerungskabel.
2. Wechseln Sie zum HDMI-Kanal.
3. Schließen Sie den Stick mit dem USB-Ladekabel an einen USB-Port oder ein USB-Netzteil an (nicht im Lieferumfang enthalten).
4. Der TV-/HDMI-Stick ist nun betriebsbereit. Die LED auf der Unterseite leuchtet blau.

## VERWENDUNG

- DLNA: in diesem Modus können Sie Videos, Musik und Bilder auf dem verbundenen Anzeigegerät aus-/wiedergeben.

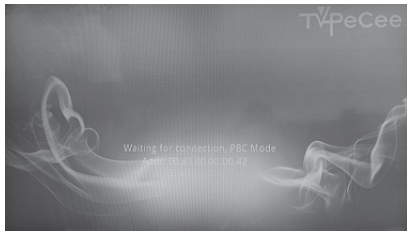
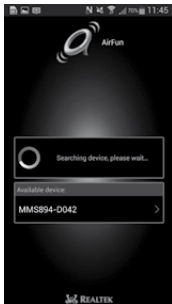
