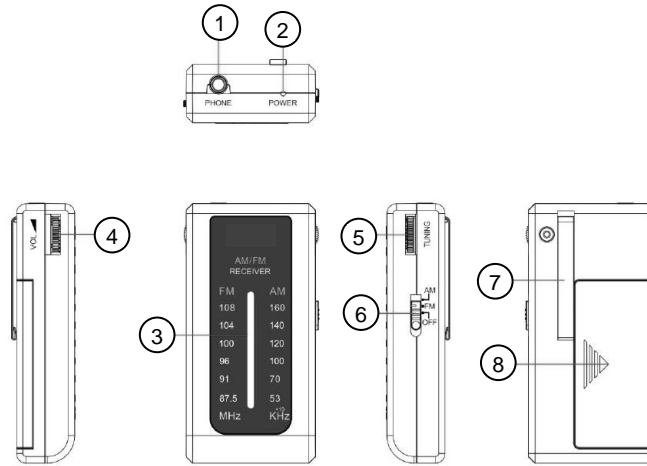

Inbetriebnahme

Batterien einsetzen

1. Öffnen Sie das Batteriefach auf der Rückseite Ihres FM/AM-Transistorradios und setzen Sie zwei Batterien Typ AAA ein. Achten Sie beim Einsetzen auf die richtige Polarität der Batterien.
2. Schließen Sie das Batteriefach wieder.

Kopfhörer anschließen

- Schließen Sie die Ohrhörer an die 3,5-mm-Klinkenbuchse Ihres FM/AM-Transistorradios an.

Setzen Sie die Ohrhörer nicht gleich ein. Stellen Sie erst sicher, dass eine niedrige Lautstärke-Stufe eingestellt ist.

- Stellen Sie die Power-Taste auf die Position „FM“, um Ihr FM/AM-Transistorradio im FM-Modus einzuschalten.
- Stellen Sie die Power-Taste auf die Position „OFF“, um Ihr FM/AM-Transistorradio auszuschalten.

Preamble

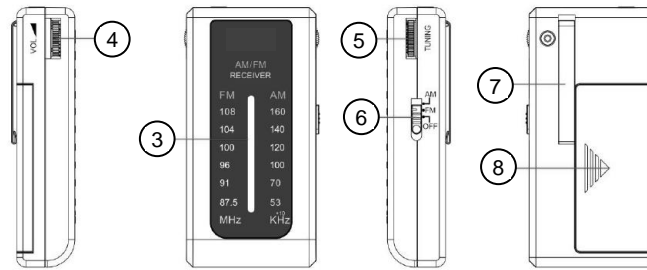
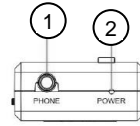

Mise en marche

Insérer les piles

1. Ouvrez le compartiment à piles situé à l'arrière de l'appareil et insérez 2 piles AAA. Respectez la bonne polarité des piles.
2. Refermez le compartiment à piles.

Brancher un casque audio

- Branchez les écouteurs sur la prise jack 3,5 mm du transistor radio.
